



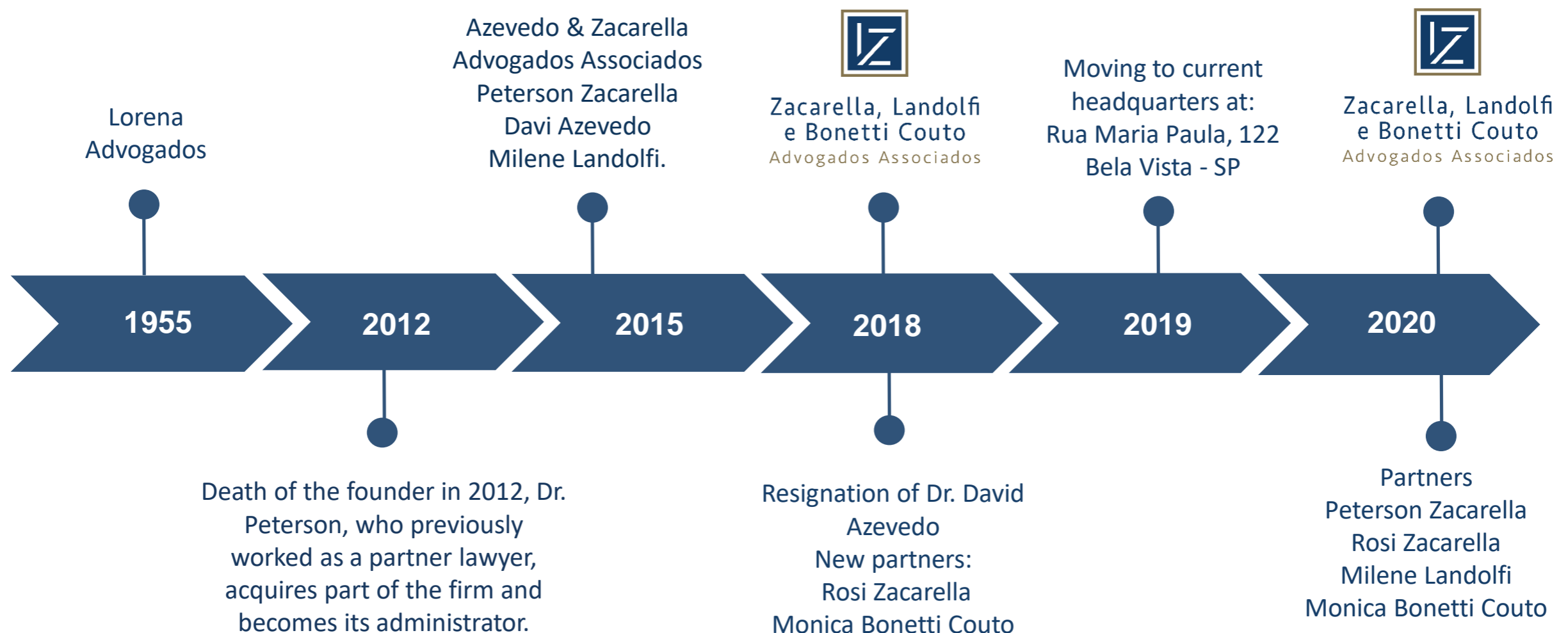

To be recognized as a reference law firm by corporate clients due to our experience, customized service and technical excellence inspiring credibility and security.

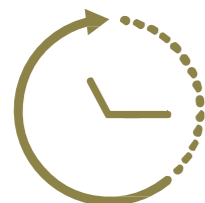
